Canopies: Please bring weights to anchor your canopy since the parking lot is blacktop

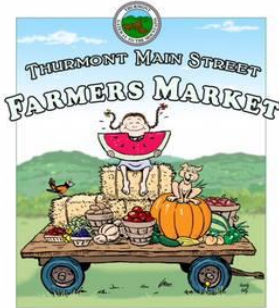
In addition, once you have been accepted you will receive (via Email or U.S. Mail) a permit from us that must be displayed during the Farmers Market each week.
